4. FIRST AID MEASURES

First aid measures

General advice

Skin Contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Consult a physician if necessary. Immediate medical attention is not required. If skin irritation persists, call a physician.

Eye contact

Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. Inhalation

Immediate medical attention is not required. Move to fresh air in case of accidental inhalation of vapors. If symptoms persist, call a physician.
